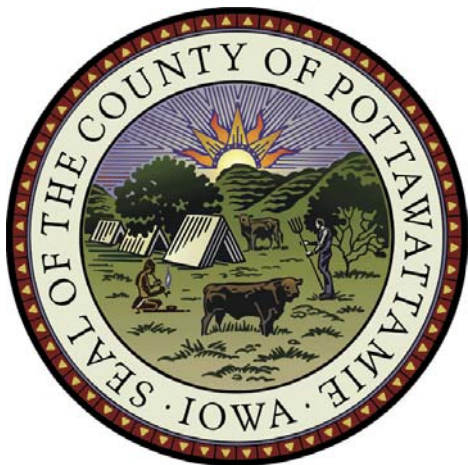

### Residential Care Facility (RCF)

Provides 24-hour supervised residential care in a group setting. Individuals receiving these services vary in terms of disability and age. The appropriateness of placement in an RCF is determined by consumer needs and facility capabilities.

### Residential Care Facility for the Mentally Retarded (RCF/MR)

Provides 24-hour supervised residential care in a group setting. This setting is designed for persons with a primary diagnosis of Mental Retardation. The structure provided is designed towards teaching the skills necessary for independent living.

### Residential Based Supported Community Living

Provides services to children who are under the age of 18 and are not able to live in their family home due to the complexity of their behaviors or disabilities. They will reside in a residential based SCL environment where they will receive services designed to assist in family reunification and to develop daily living and social skills.
